PPC Member Student Scholarships Application Deadline is April 1st!

PPC offers two \$2,500 scholarships for children of PPC members in good standing. Applications are being accepted now (from January 1 - April 1). This is a great membership benefit to take advantage of. Two children of members will be awarded the scholarships in June. Your child, regardless of major, may qualify.

The first step is to order your child's transcripts, which need to be delivered directly from the school to the PPC Office.

Here are the main qualifications:

Applicants must be either: (1) a child of a Regular or Associate individual member of the PPC in good standing for the year in which the application is received; or, (2) a child of a designated representative of a Regular or Associate corporate member of the PPC in good standing for the year in which the application is received.

- Enrolled at a four year accredited university or college (or accepted to a four year accredited university or college if the applicant is an incoming freshman).
- 3.0 minimum cumulative G.P.A. (on a 4.0 scale) in current college (or high school if incoming freshman).
